#### GOVERNING PROVISIONS

#### ITEM 110 **DEFINITIONS**

- (a) The term "holiday" as used herein means: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.
- (b) A "shipment" consists of a quantity of freight tendered to the carrier by one consignor at one place at one time for delivery to one consignee at one place on one shipping document, except as otherwise provided.

#### ITEM 120 COLLECT ON DELIVERY (COD) SHIPMENTS

When carrier is requested to perform COD service in connection with a shipment, carrier will perform said service at a minimum charge of \$50.00. The charge will be in addition to all other lawful charges. Any COD where we are collecting charges for our customer from the shipper and the charges are collect, and *the consignee is unfamiliar*, our driver needs to collect the full FCCOD charges at the time of delivery.

#### ITEM 130 GUARANTEE

Next day delivery to all points served throughout Illinois and Wisconsin by 5pm.

#### ITEM 140 GUARANTEED EARLY DELIVERY CHARGE Shipments requiring guaranteed early delivery before 1700 will be charged \$125.00

#### ITEM 150 OVER LENGTH FEE

When a piece is over 7 feet but no longer than 11.999 ft - \$200.00 When a piece is over 12 feet but no longer than 15.999 ft - \$325.00 When a piece is over 16 feet but no longer than 19.999 ft - \$500.00 When a piece is over 20 feet – please call for a quote

The above over length surcharge will be added to the freight charges. One surcharge per total freight bill.

#### **ITEM 160 DETERMINATION OF MILEAGES – PC MILER WILL BE UTILIZED**

# ITEM 170EXPLOSIVES AND OTHER DANGEROUS ARTICLESWill be handled in accordance with the regulations published in Title 49 CFRParts 106, 107, 146, 171 thru 179, and 397, as applicable. A \$70 charge will beapplied per shipment

#### **ITEM 180** HOURLY RATES, COMPUTATION OF

Charges based on time shall be computed by multiplying the hourly rate by the time involved. Unless otherwise provided, fractions of an hour will be disposed of as follows; where the time involved is 15 minutes or less the charge shall be for one quarter of an hour. When in excess of 15 minutes but not more than 30 minutes, charged for one half hour. When in excess of 30 minutes, but not more than 45 minutes, charged for three quarters of an hour. When in excess of 45 minutes, charges for one hour.

#### ITEM 190 SPECIALS

**CONTROL AND EXCLUSIVE USE OF VEHICLE** (not applicable requested on a unit of time basis).

EXCLUSIVE USE OF A VEHICLE OR SPECIAL SERVICE REQUESTED When the exclusive use of a vehicle or special is provided by the carrier and is performed at the request of the consignor or consignee, on other than a unit-of-time basis, the following provisions will apply:

- 1 Charges will apply to each vehicle used to transport the shipment.
- 2 The request must be given in writing or placed on the bill of lading and the shipping order, or verbally communicated with a contact name.
- 3 All specials will be calculated in the following manner:
  - 1. Add minimum \$125.00 to the freight charges **OR**

2. Rate per mile based on the miles from JA Frate in Crystal Lake,

IL to the shipper, to the consignee and on the weight & type of

vehicle necessary to transport the shipment as outlined below.

d. Shipments that are not delivered directly but require a specific delivery time prior to 5pm on the next business day will be charged the normal freight charge plus the "Special" charge of \$125

4 - Charges are to be paid or guaranteed by the party requesting the services and the non-recourse stipulation on the bill of lading may not be excluded, the charges may exclude the trailer load rate.

#### In no case will the charges for a special be less than the rate for a next day shipment

ITEM 210 IMPRACTICABLE OPERATION (is also determined by weather conditions) Impracticable operations will be determined when the majority of schools are closed in the area due to weather will be implied that impracticable weather conditions are in effect and any tariff agreements are not standing. Impracticable operation is also determined by the carrier.

#### ITEM 220 NOTIFICATION PRIOR TO DELIVERY

Shipments on which consignor or consignee has requested carrier to give notice prior to delivery or to call ahead to pre-schedule a delivery time will be assessed at the additional charge of \$44.00

#### **ITEM 230 DETENTION AND WAITING TIME**

- (a) Except as otherwise specifically provided, when loading and unloading of freight at or on the premises of the consignor or consignee, or at a place designated by the consignor or consignee for receipt or delivery of freight, is delayed, and said delay is directly attributed to the consignor or consignee, or others designated by them, the provisions of this item apply.
- (b) If the loading and unloading of freight is delayed beyond the following free time, a charge of \$25.00 per vehicle for each 15 minutes or fraction thereof, will be made for the time consumed in such delay:

- (c) Computation of time required to load or unload shall commence with the arrival of the carrier's vehicle at the area designated or from the appointment time and with its departure.
- (d) A record of the following information must be maintained by the carrier and kept available at all times;
  - (1) Name and address of consignor or consignee at whose place of business freight is loaded and unloaded.
  - (2) Identification of vehicles tendered for loading or unloading information is as to power unit being attached or not.
  - (3) Date and time of arrival of the vehicle for loading or unloading, and the name of the driver making placement.
  - (4) Date and time vehicle is released for departure by consignor or consignee after loading or unloading is complete and name of party authorizing release of equipment.
  - (5) Total actual weight of shipment loaded or unloaded.

#### ITEM 240 OPERATING RIGHTS

The rates, rules and regulations names in this tariff will apply to all points covered direct through air, ocean, surface, interline, or expedited.

#### **ITEM 250 PICKUP OR DELIVERY NOTICE**

The rates names in this tariff include pickup and delivery service for all direct points served.

#### ITEM 260 ADDITIONAL LABOR REQUIRED

Anytime that there is an additional need for an additional driver to make a pickup or delivery or for any purpose in the movement of transportation, the additional labor for that driver or helper will be assessed at \$55.00 per man hour and a minimum of 4-hours.

#### ITEM 270 TRAILER LOAD RATES

Except as otherwise provided, the maximum charge for a single shipment transported on one vehicle shall in no case be greater than the charges listed below, unless these shipments are specials or exclusive use:

1-20 MILES- \$90.00 21-40 MILES- \$167.00 41-60 MILES- \$241.00 61-80 MILES- \$281.00 81 MILES AND UP WILL BE CHARGED AS A FULL LOAD RATE

\*\*\*\*\*\*\*

\*\*\*EXAMPLE- SHIPMENT FROM BOLINGBROOK BACK TO CRYSTAL LAKE WITH 3 STOPS IN BETWEEN, ELK GROVE, BARRINGTON AND FOX RIVER GROVE: CHARGE NORMAL TRAILER LOAD RATE FOR RUN BETWEEN BOLINGBROOK AND CRYSTAL LAKE BY MILES: THEN BOLINGBROOK TO ELK GROVE, ELK GROVE TO BARRINGTON, BARRINGTON TO FOX RIVER GROVE., CHARGE ADDITIONAL STOP CHARGES BY THE MILES FOR THESE THREE POINTS IN BETWEEN \*\*\*

Note – charge in dollars to be added to the charge for 140 miles for each 10 miles or fraction thereof over 140 miles is \$14.00. Utilize the trailer load rates on exclusives when these rates apply to beyond areas covered by J.A. Frate. Rates based on special compare with beyond trailer load rates listed and utilized whichever is higher.

Specials may exceed the trailer load rate.

#### ITEM 280 PALLET EXCHANGE

The minimum charge for pallet exchange is \$19.00 per non-heat-treated pallet and is to be charged to whoever is paying our invoice. There are times when there is no pallet exchange noted and we may have to buy pallets from a forwarder. In those cases, we will charge the exact amount back to whomever is paying the invoice what we are being charged by the forwarder.

#### ITEM 290 SHIPMENTS REQUIRING FLATBED TRAILERS

When shipper tenders carrier a shipment that requires the use of a flatbed trailer in order to transport it, such shipment will be subject to a charge per vehicle used as follows:

#### <u>Monday- Friday 06:00 – 17:00</u>

\$125.00 per hour, rounding up to the next <sup>1</sup>/<sub>4</sub> hour plus the current fuel surcharge.

#### <u>Monday – Friday Before 06:00 and after 17:00 and all day Saturday &</u> <u>Sunday</u>:

155 per hour, rounding up to the next  $\frac{1}{4}$  hour plus the current fuel surcharge. 4 hour min charge.

Time is calculated from the time the driver leaves JA Frate in Crystal Lake until the time that he returns to JA Frate.

#### **Alternative Pricing**

When non hourly pricing is requested for a Flatbed shipment use Trailer Load rates as shown under **Item 270**. There will be one hour free on each end. All additional time is billable at \$125.00 per hour. Mileage based fuel surcharge will be added. Mileage calculations will be between shipper and consignee for this pricing only.

#### **ITEM 300 PICKUP OR DELIVERY SERVICE TO PRIVATE RESIDENCE**

When shipper or consignee request carrier to make a pick or delivery of a shipment at a private residence, carrier will perform said service at an initial charge of \$100.00 per shipment for each such service performed (excluding customers with the exception of any exclusions noted, example: Uline).

#### **ITEM 310 PICKUP OR DELIVERY SERVICE – SUNDAYS OR HOLIDAYS AND** AFTER NORMAL HOURS

When a carrier is requested by shipper or consignee to perform transportation services on Sundays or holidays, or any time after 17:00 and before 08:00 there will assess a minimum additional charge per vehicle used as follows: (a) Monday thru Friday 1701 - 0759 \$155.00

(b)	Saturday 0800 -1700	\$155.00
(c)	Saturday 1701 – 0759	\$205.00
(d)	Sunday and holidays 0800 -1700	\$230.00
(e)	Sunday and holidays 1701 – 0759	\$280.00

#### ITEM 320 RE-DELIVERY OF FREIGHT

When tender of delivery of a shipment has been made by carrier during business hours of consignee and delivery cannot be accomplished, through no fault of carrier, and re-delivery is necessary and additional charge for each attempted re-delivery will be assessed at 100% of the applicable freight charges for the initial attempted delivery.

#### **ITEM 340 RETURNED, UNDELIVERED SHIPMENTS**

If, for any reason, a shipment which was transported outbound by the carrier is refused, rejected or returned by the consignee at destination, it may be returned to the point of origin upon order of the shipper and 100% of the outbound rate in effect on the date of the retuned shipment will be assessed on the return haul. The regular applicable rate will be assessed form origin to destination on the outbound movement.

#### ITEM 350 ATTEMPTED PICKUP

If, for any reason a shipment cannot be made at the shipper's location, the shipper will be charged  $\frac{1}{2}$  the outbound rate. Any accessorial charges pertaining to the pickup only will be charged at 100% of the accessorial charge, or charged  $\frac{1}{2}$  the rate if accessorial pertains to the entire shipment.

#### ITEM 360 ATTEMPTED PICKUP / DELIVERY

Attempted pickup or delivery charge will not drop below the minimum rate applicable

#### <u>ITEM 370</u> ATTEMPTED PICKUP / DELIVERY – SPECIAL OR EXCLUSIVE USE For special or exclusive use of a vehicle, the full rate will apply when for reasons not due to carrier performance the shipment cannot be either picked up or delivered.

#### ITEM 380 INSIDE DELIVERY

Except as otherwise provided in particular rate items, when carrier is requested to make an inside delivery there will be assessed, in addition to all other lawful charges billed \$25.00 per 15 minutes.

#### ITEM 390 LIMITED ACCESS DELIVERY- \$100.00

Pickup or delivery in Chicago Loop, camps, carnivals, churches, colleges, construction sites, fairs, individual/mini storage units, mosques, schools, synagogues, temples, and universities. Also includes commercial establishments not open to the walk-in public or where an employee is not available to assist in the loading or unloading. Will not apply for shipments from or to schools,

colleges, or university bookstores with normal receiving hours and where an employee is readily available to assist with loading or unloading.

#### **ITEM 400 STRAIGHT TRUCK** : \$125.00

#### ITEM 410 LIFT GATE EQUIPMENT

When shipper or consignee requests carrier to furnish a vehicle equipped with a hydraulic lift gate; carrier will provide said equipment at the additional charge of \$105.00. 1,200# maximum per skid

#### ITEM 420 CORRECTED BOL \$20.00

#### ITEM 430 CROSS DOCK LABOR FEE:

\$25.00 per 15 minutes, billed in 15-minute increments.

# **ITEM – 450 DECLARED VALUE-FULL VALUE COVERAGE INSURANCE CHARGE:**

The shipper must request the coverage in writing on the Bill of Lading at the time of the shipment providing the invoice value of the goods.

Declared Value + the Freight Charges + 10% / \$100 x \$.85, per package. Charged if value exceeds standard liability;

Surface Standard Liability of \$25 per pound, per package or \$100,000 per shipment, whichever is less. Standard Air & Ocean Liability is \$.50 per pound. This only applies to new items, not refurbished, or used.

#### **ITEM – 460** WEIGHTS, WEIGHING, REWEIGHING AND RECLASSIFICATION

WEIGHTS TO BE USED – except as otherwise specifically provided, charges will be computed on actual gross weights. When estimated weights are authorized, such weight shall be used.

All shipments handled by JA Frate are subject to inspection at any time for any reason. Upon inspection, JA Frate reserves the right to confirm that the shipment contains the item described on the Bill of Lading, including the correct weight and/or freight class.

Any shipment inspected by JA Frate that results in a correction to the Bill of Lading by either the weight or freight reclassification will carry additional charges as follows:

- 1. WEIGHING AND REWEIGHING If the shipment is under by more than 50 lbs, a \$25.00 reweigh fee will be assessed. If the shipment is over by more than 50 lbs, a \$20.00 fee for every 50 lbs over will be assessed.
- RECLASSIFICATION All shipments will be audited to ensure they are the correct freight class. The following calculation will be used to find the density in pounds per cubic foot: length x width x height x units/1728 = cubic feet; weight (in pounds)/cubic feet = density in pounds per cubic foot. If no NMFC

# or wrong NMFC # is given on BOL, we will reclassify the freight based on density per pound. The below chart will be used to determine the proper freight classification. Any additional charges will be applied if the reclassification changes the freight rate.

EXCEPTIONS TO NMFC –When the National Motor Freight Classification publishes a "0" rating for a commodity, the applicable rate shall be rated on class 250.

### ITEM 470 UNIT OF TIME RATES

When exclusive use of vehicle is requested on a unit of time basis and rates are published in this section will apply regardless of weights between the same points or the same routes published in other sections, such as McCormick Place, Rosemont Expo, Etc. Shipments going to any show will be billed as follows:

- Regular surface rates apply per vehicle
- Add special charge as applicable
- Waiting time will be charged as applicable
- Add marshaling fees

UNIT OF TIME RATES – (hourly rates in dollars) EXCLUSIVE USE OF EQUIPMENT (a) When a shipper desires the exclusive use of a carrier's equipment on a daily or per trip basis, charges shall be computed as follows:

- (b) Hourly charges apply from the time driver leaves carrier's terminal until he returns to carrier's terminal.
- (c) Daily minimum charge 4 hours.

#### ITEM 490 TRAILER DROP AND RENTALS

Any customer requesting a trailer drop will be charged a fee of \$100.00 per hour with a one hour minimum, plus fuel if they are loading freight for us to deliver and they will not have the trailer in their possession for more than 3 business days. If the customer will have the trailer in their possession for more than 3 business days the weekly rental fee will apply including the drop fee.

#### ITEM 500 STORAGE TRAILERS

A trailer drop fee will be billed \$100.00 per hour from the time the driver leaves JA Frate back. A trailer pickup fee will be billed \$100.00 per hour from the time the driver leaves JA Frate back. A monthly rental fee of \$425.00\* per "non-roadable" unit will apply. Storage trailers parked at a JA Frate facility will be charged an additional \$100 per month Road-able trailers are billed at \$650.00\* per month.

\*1-month minimum charges, pro-rated, after 1<sup>st</sup> month to the 15<sup>th</sup> or 30<sup>th</sup>.

These rates are subject to availability and special requirements.

#### ITEM 510 STORAGE CHARGES

If freight should sit at any J.A.FRATE location for more than 2-days (THIS DOES NOT INCLUDE THE PICKUP DATE) storage fees will apply. This 2day rule applies to NORMAL BUSINESS HOURS ONLY AND THE CHARGE TIME WILL START THE FOLLOWING DAY AFTER THE FREIGHT HAS BEEN PICKED UP. The storage fees applied will be equal to our normal warehouse charges of \$25.00 per skid, per day. Freight that does not apply to this rule would be: Freight held due to our discretion After 2-days this freight will be moved into the warehouse. If the freight is in a trailer then the monthly trailer rental fee of \$650.00 will apply

#### ITEM 520 BLIND SHIPMENT

when a third party controls the movement of the freight but does not want the shipper or consignee to know the name of the other. The original bill of lading from the shipper must show the actual shipper's name, address, city, state and zip code consigned to the Carrier's terminal serving the shipper. The corrected bill of lading will identify specified company as the shipper with the shipper's city, state and zip code and the actual consignee's name and address. The corrected bill of lading must reflect a Third Party; which must have established credit with Carrier. The invoice is generated from the Corrected bill of lading. Carrier will not ensure the confidentiality of the transaction. The charge for this service will be \$75.00 conjunction with all other applicable charges. Carrier must be satisfied that the requestor has the legal authority to divert the shipment. Carrier will make a diligent effort to execute a request for Blind Shipment, but will not be responsible if such service is not affected.

#### ITEM 530 DOCUMENT PICK UP

When carrier is requested to retrieve documents prior to pick up or delivery at a reasonably located alternate location. The charge for this service is \$25 per 15 minute increments.

#### ITEM 550 PROTECT FROM FREEZE

If the carrier is instructed to protect from freeze on the Bill of Lading. The shipment will be transferred to our heated warehouse. JAFrate is not equipped to protect from freeze while the shipments are in transit. Our trailers are not heated and we assume zero liability for the transit temperatures. The charge for this service is \$50 per day per pallet including weekends.

#### **ITEM 560 TARPING FOR FLATBED SERVICE (FLAT RATE ONLY)**

When the driver is required to tarp a flatbed shipment where a flat rate has been assigned the charge for this service is \$150.00

#### ITEM 600: FUEL SURCHARGE

Anytime the fuel price rises above 1.10 the following scale will be implemented. The fuel surcharge is applied after all applicable discounts. Fuel surcharge is changed weekly based on the D.O.E. Midwest Average.
